
Round 1 SRA By-election: **514 (3.6%) of 14202**

undergraduate emailing lists, we sent out individualized emails to each specific faculty to disseminate how many seats were open and the appropriate deadlines and dates. To target the Nursing, Kinesiology, and Arts & Science students (who did not have any SRA representatives), we also reached out to members of their respective societies to help spread the word. Additionally, by ordering a Digital + Print package from the Underground, we circulated posters around campus, and social media posts on Instagram, Facebook and Twitter.

Due to open seats in Engineering, Humanities, Social Sciences, Kinesiology, and Nursing, we employed a similar strategy as the first week to garner nominations for the extended period. Instagram stories and reminder emails were also used to remind students of the upcoming nominations deadline.

There were also open seats still available from the FYC election. To promote these, we emailed students for the two specific buildings (Edwards and Woodstock) and used social media posting to promote the campaign.

Overall, after two rounds of nominations we were able to fill up all spots besides one Humanities seat and the Edwards Residence Chair seat from FYC. We are content with the level of interest generated. Moving forward, we'd like to facilitate more in-person promotions such as additional tabling or events to increase awareness.
