SUBJECT: Operating Policy – Interfaith Council

Dear Members of the Assembly,

One of the policies the committee has reviewed this year is for Interfaith Council, which was last reviewed five (5) years ago. The Interfaith Council brings together student representatives from various faith-based groups in the McMaster community to address issues and build relationships to encourage spiritual dialogue. In collaboration with Mitchell (VP Admin), Victoria (Administrative Services Coordinator) and Daniela (Executive Assistant), I propose the edits outlined below.

Similar to the MSU Governance and YOU edits, we feel that the Interfaith Council Chairperson role should not be obligatory for the Diversity + Equity Network Director. Instead, we propose that either the Director or the Assistant Director be part of the committee, and that the Chairperson be elected by the council from within their membership. Other changes include routine updates to the names of MSU student groups, as outlined below.
