**7. Approve the allocation of items from the 2022-2023 Capital Budgets**

**Moved** by Chui, **seconded** by Abdallah that the Full Members of the Corporation approve the allocation of items from the 2022-2023 Capital Budgets, as circulated and presented.

- Chui said the first thing was to allocate the budgets towards the capital spending and then approve for spending. She informed that a Capital Budget is something that would depreciate over time, for example computers. She clarified that the Operating Budget is for the year, whereas the Capital Budget is for long-term purchases. She informed that this did motion did not pass at SRA 22C due to not having a 2/3 majority vote. She said that, as a result, the Capital Budget was circulated to herself, and as VP Finance, she can approve any purchases under \$2,000, according to Corporate Bylaw 3. She added that the remaining budget was moved to Executive Board, who can approve anything under \$5,000. She informed that all capital expenditures under \$5,000 were approved by EB and clarified that added that anything over \$5,000 must be approved by the Assembly. Chui stressed the importance of passing the budget, especially for Services who may need renovations/repairs - they are unable to get things done unless this budget is approved.
- Abdallah did not speak to the motion.

- Wong stressed the importance of passing the budgets as some staff have been waiting for seven weeks who have not been able to do their job. Wong said this is the responsibility and duty of an Assembly member.
- Chowdhry echoed Wong's statement.
