Information Period

Wong informed that the official Municipal election day is on October 24th. They informed that a mayoral debate is taking place in the MUSC Atrium tomorrow from 2:00-4:00pm. They said they would be presenting mayoral candidates with questions. They added that there will be a polling station on the third floor of MUSC in CIBC Hall on October 18th and noted that anyone from across Hamilton could vote, regardless of which ward they resided in. They added that it was a great opportunity that the city has provided and highly recommended the Assembly to vote at this station to increase numbers and show engagement. They said that if voting numbers are kept high, the city would continue with the on-campus polling stations in the future. They clarified that individuals renting a house can vote in Hamilton in addition to voting in their hometown, as they are paying taxes into both. They said they were still looking for volunteers for the polling stations.

Question Period

 Caputo asked if someone could vote at the on-campus polling station if they were renting in Hamilton, even if they received a ballot in their hometown, but have not yet voted. Caputo ceded time to Wong. Wong answered that they could vote in both their hometown and in Hamilton at the on-campus station if they are renting in Hamilton or living on residence as they are paying into taxes in both areas.
