Brandon responded that their office gives the highest level of impartiality and confidentiality and provides the service of generating options. She explained that the Ombuds Office was an oversight office that helps the student navigate the bureaucracy, and to ensure that everyone has been treated fairly.

7. CASA Observership Status

Moved by Singh, **seconded** by Wong that the Assembly approve the MSU's observership the Canadian Alliance of Student Associations (CASA).

- Singh went over the memo circulated with the Assembly.
- Wong felt that Singh summarized the memo very well. They explained that this took a lot of consultation and this has been a conversation since October. Wong stated that with this status the MSU will be able to attend CASA's conferences. They felt that this would help them cover all of their bases.
- Singh re-iterated that there wouldn't be any fees associated with being an observer with CASA, only if they join as members.
- Dawdy stated that the UCRU Lobby Week report and the CASA motion have a bit of tonal dissonance, where UCRU seemed great in the report but now not so much. Dawdy ceded their time to Singh.
- Singh responded that the reports were written by separate individuals and reflects their writing styles.
- Hu asked if UCRU has a better future in gathering and support. Hu ceded their time to Wong.
- Wong responded that UCRU looks great on the outside, but is internally struggling. They added that there wasn't a clause in policy that denies the MSU being a part of both. They explained that the BoD would like to be observers for the General Assembly for CASA, and that Western, Queen's, UBC, and Wilfred Laurier are putting in their observer requests too. Wong added UCRU was struggling, but that the MSU wasn't abandoning it, and that they are just making sure they can make the best decision on federal advocacy.
- German asked about what commitments would entail from the BoD, as well as any associated fees.
 German ceded to Singh.
- Singh responded that CASA does a series of yearly events, so the MSU will have to pay for items such as travel and accommodations.
