Amendment

- Abbott explained that a few members of the Science caucus have to leave due to another commitment and wanted to move this portion of the election so that the members in question are able to vote.
- German said he wanted to get as much done today as possible and thought it was unfair to have the candidates wait until tomorrow. He expressed opposition to the motion.
- Wong said this type of motion is standard in past elections and said that this was done when she was Speaker. She felt it is important to get proper representation from all caucuses. She added that both Saturday and Sunday are booked for this specific meeting, and it is a part of Assembly members' responsibility to go through with it.
- Chui felt that the Vice-Presidential candidates should not have to wait until the next day.
- Abbott stated that the members in question need to leave at 12:45pm.
- Singh stated that Assembly members have an obligation to attend meetings and felt it was unfair. He noted that this is why absences are allowed for. He added that this should be discussed closer to the time in question and did not feel it was a reasonable proposition.
- German said it was unfair to the candidates and to everyone that showed up early in the morning on a weekend in order to follow the election.

- Hannan felt the election should proceed as outlined and felt they should get as much possible done today.
