The main propositions are to move the department under the purview of the Administrative Services Coordinator, and clarifying the Votes of Confidence election timelines for FYC and SRA. In addition, there are several proposed grammar edits.

These changes were proposed by the Administrative Services Coordinator, with input from the Executive Assistant, the 2022-23 CRO and DRO, as well as the 2022-23 and current Board of Directors.
