- Singh reiterated that General Assembly was approaching and that it is the highest governing body of the MSU where student insight is received. He added that the Speaker has already put in a lot of work into it, and it would be great to have the opinion of an SRA member. Singh said it is low commitment and would be wrapped up by mid-March.
- Chui said that it is important that General Assembly is planned smoothly this year and encouraged Assembly members to attend. She reviewed the duties of the Sponsorship & Donations committee.

## 1. Proposed changes to Operating Policy - MSU Governance and You Committee

**Moved** by German that the Assembly approve the changes to **Operating Policy - MSU Governance and You Committee**, as circulated.

German reviewed the memo with the Assembly.

## 2. Proposed changes to Operating Policy – Interfaith Council

**Moved** by German that the Assembly approve the changes to **Operating Policy – Interfaith Council**, as circulated.

- German reviewed the memo with the Assembly.
- Chui asked how the membership status is determined and who picks the groups that are listed in the policy. Chui ceded her time to German. German explained that no groups were removed from the policy and said he personally did not select the groups, nor did the Internal Governance committee, that is just what the policy states. He said that if Chui felt a major religious group was being excluded, she could voice her concerns to the Internal Governance committee and changes could be made if necessary. He clarified that all of the same groups were kept, with the exception of the Catholic Students Association (CSA) being replaced with Canadian Martyrs Catholic Church & Chaplaincy, as the CSA no longer exists.
- Chui asked if it was possible to review the membership status as there are 19 religious clubs on campus. She understood that it was fair to pick a religious group from each religion but thought within each religion there are contrasting values. She suggested a rotational system so that each year, a different club from that religion would have a seat at the table. She added that if a club did not finish the ratification process and got de-ratified, they wouldn't be able to sit on this council.
- German felt that a rotating basis of groups would make the policy extremely complex/outdated as policies are reviewed approximately every three years. He added that if they consistently needed to be updated, they would be breaking the policy, or it would be outdated and would also put a strain on administrative capacities. German clarified that those listed are voting members and others could still sit in on the committee.
- Singh personally felt that the changes were administrative in nature and thought the point Chui brought up was reasonable.
- Chui said her concern was that the groups chosen to be voting members are not actually representative of their religion. Chui asked what the process is if the policy is referred back to the Internal Governance committee. Chui ceded her time to German.
- German explained that the Internal Governance committee would review the policy, and provide the Executive Assistant, Administrative Services Coordinator and Vice-President (Administration) with two days to also review the policy and then it would be sent to the SRA with five days' notice. German clarified that if the Internal Governance committee didn't agree with the changes, they did not have to make them.
- Chui stated she has no problem with the current changes and asked to motion to refer back to the Internal Governance committee.
