- 1. Purpose
  - 1.1 To define the membership, duties, <u>purpose</u>, and procedures of the President's Council.
- 2. Membership
  - 2.1 Membership shall comprise of:
    - 2.1.1 The MSU President (Chair);
    - 2.1.2 Presidents or designates of the following academic division societies, and those who fulfill the following criteria, upon the President's discretion:
      - 2.1.2.1 Program societies with direct entry for first years.

- 3. Duties, Purpose and Procedures
  - 3.1 The Council shall:

Approved 95G Revised 96Q, 97R, 98L, 98N, 99P, 08I, 08P, 10N, 11M, 15G, 19B

- 3.1.1 Discuss University issues and policies affecting undergraduate students at McMaster, with an emphasis on policies and issues affecting student life outside of academics;
- 3.1.2 Advise the MSU President on possible improvements to University policies;
- 3.1.3 Receive written or verbal reports from members outlining the activities and concerns of their constituencies;
- 3.1.4 Provide recommendations to other councils, committees or organizations dealing with issues discussed at President's Council meetings:
- 3.1.5 Meet a minimum of three (3) times per term:
  - 3.1.5.1 Terms are: September 1 December 31; January 1 April 30
    3.1.5.13.1.5.2 Prior to the first meeting of the term, academic division societies can rescind their seat by informing the MSU President.
- 3.2 The Council shall be exempt from any quorum requirement.
- 3.23.3 Attendance records shall be kept by the Chair, which can be available available upon request, and posted on the MSU Website
