Suganthan reported that SHEC will have their volunteers trained for peer support by October 1. ## **Business**

### **1. Proposed changes to Operating Policy – Business Related Expenses**

**Moved** by Masudi, **seconded** by Yang that the Assembly approve the proposed changes to **Operating Policy – Business Related Expenses**, as circulated and attached.

- Masudi went over the memo with the Assembly.
- Yang stated that they have travelled before with the previous limit. They felt that \$80 was a large amount for a one-day expense but felt that it was better to have a higher ceiling as there are those with dietary restrictions. They stated that it comes down to approximately \$26 per meal, which they felt wasn't excessive. Yang stated that having the daily expense be \$80 a day wasn't misusing student money as everyone has to eat, and felt that it was possible to go above the \$65 amount each day if they bought coffees, breakfast, lunch, and dinners.
- Abbott agreed with Yang. They stated that they have been on other daily expense budgets when working with the school board and members would be fighting to stay within their budget. They added that going to conferences someone might want to account for buying snacks for other students. Abbott felt that \$80 was not an excessive amount to budget for each day, and a lot of conferences are held in bigger cities and those meals become more expensive.
- Hannan felt that this was an interesting motion to be made now as it was just recently passed with the \$80 limit. They felt that this was a good learning moment for the SRA and felt that this was a very fiscally responsible choice that Popovic brought forward.
