
# **Voter Turnout**

Voter turnout for the 2023 FYC election is as follows:



# **Promotional Events & Strategies**

### **Nominations Promotion**

This year, the nomination period for the MSU FYC Election ran from September 5<sup>th</sup>, 2023 until September 18<sup>th</sup>, 2023.

We ordered a Digital + Print package to promote through online and on campus channels, including a window banner and MUSC banner. On Instagram, Facebook, and Twitter, graphics detailing the positions available and important nomination/voting dates were circulated during the first week of nominations. In the second week, social media stories and emails were used to communicate the upcoming deadline and encourage the submission of nomination forms. Printed posters were put up around campus, primarily in MUSC. Rave cards were also distributed. Finally, campus media screens also displayed information about the FYC elections.

In addition, a variety of on-campus resources were utilized to promote the election. Several events were held on campus throughout the nomination period. Elections and FYC both had a table at ClubsFest. Another event, the FYC Meet and Greet, was held in collaboration with FYC, where first-year students had the opportunity to ask questions about how to run as well as the experience of being on FYC. Chips and juice were provided at this event. Lastly, Elections 1A03 was held by the Elections Department on two days, where prospective candidates could learn more about strategies for running a



successful campaign and how to get involved in the school. Snacks were also provided at this event. Rave cards were distributed at all of the events.

Due to unfilled positions for Bates, Hedden, Les Prince, Moulton, PGCLL, Whidden, and Off-Campus/Commuting Student representatives, nominations for these specific positions were extended one additional week. Promotional efforts for these reaching these students included additional emailing, and specific targeting of certain demographics. For example, we contacted CAs for these residences to promote the election.

Overall, by working with the MSU Communications Team to develop a hybrid promotional strategy, we were content with the awareness and interest generated in the MSU FYC Elections.

# **Updates**

## **Rule Changes/Clarifications**

Election rules for posters were added to the bylaws to accommodate transition back to in person.

# **Challenges**

A challenge we had was regarding voter and event turnout. Despite our best efforts to promote this election through several in-person events, some events had low attendance and voter turnout was lower than last year for the Chair and Vice-Chair positions.

Additionally, the Vice-Chair Events election was re-run due to a mistake during election set-up.

# **Appeals Process In Progress**

The appeals process for this election is ongoing. Two candidates running for Chair and McKay Hall Residence Chair were disqualified from the initial

election. Three candidates chose to appeal their violations and fines from the first elections committee fines night meeting.

One of the disqualified candidates' appeals were resolved at the extended nominations fines night meeting due to a mistake on our department and was reinstated in the election.

The other two candidates who chose to appeal must submit their appeal documents by October 17 and will be appealing their fines to the Elections Committee on October 20. Following this meeting, a second decision will be made about their fines and violations. Candidates can then decide to appeal again to the Electoral Appeal Board.

### **Candidate Reimbursement**

Our department will contact the accounting office to begin reimbursing all candidates their originally deposit minus any fines accrued during the election.
