   Samuels said they were very excited for the Fall GA and added that the Winter GA is being hosted at McMaster and noted there would be additional opportunities to get involved.

# **Announcements from the Chair**

• The Chair welcomed everyone to SRA 23H. They advised that the by-elections are approaching soon. They added that they will send the schedule for recap graphics after this meeting.

### **Delegations from the Floor**

#### **Set Parameters**

**Moved** by Otchere, **seconded** by El-Kadi that the Assembly set parameters for both delegations to be 10 minutes for presentation time, 15 minutes for questioning, and a 30-second response time per question.

Otchere wanted to ensure enough time was given to each group.

# **Vote on Parameters**

- 1. Engineers Without Borders Sunehra Mehrun and Mahirah Rahman presented
  - Engineers Without Borders reviewed their presentation with the Assembly.

# Questions

- Hannah asked for a breakdown on the \$2,000 allocated for swag and prizes. Mehrun said that last year, it
  was broken down in a few hundred dollar increments and said it was their most popular items.
- Batusic asked what is done for students outside of Engineering in terms of engagement. Rahman
  answered all that one does not have to be in Engineering to join the team and that this is promoted at
  their events.
- Arora asked the presenters to expand on the \$2,500 allocated towards the Sustainability Case Conference. Mehrun stated that they are doing something new this year, where it is a smaller case conference, and that funding will be used for swag and prizes. Mehrun said they are unsure if they'll need that much money though.
- Abbott asked who sets the budget for the Canada Africa Fellowship. Rahman answered that it is set by national office and either they provide it, or applicants fend for themselves.
- El-Kadi said it was not fiscally responsible to have that much for swag and prizes and asked for elaboration. Rahman answered that last year, they spent around \$4,000 and most of the money went towards prizes. They added that the budget outlined for the Sustainability Case Comp is a very rough number as it is their first time doing it.
- Yang asked about the Canada Africa Innovation Fellowship and if the funding received from student fees and the \$4,000 received from the MSU is a good use of student money to send to one or two people to Africa. Rahman answered that yes, it is a good use because when the fellow is in Africa they represent McMaster University internationally. Mehrun added that they do not plan on funding the entire trip this year and will ask national office to cover some of the cost.
- Hannan mentioned the leadership struggles in recent years and asked if they have something set up to ensure they don't face this issue again. Rahman answered that they did create a computer drive that contains all the resources and that it's been a much smoother transition this year. Mehrun added that they are much more organized with their finances/budget.
- El-Kadi asked what has been done differently than previous years in terms of garnering funds. Rahman said most comes from donations and sponsorships and last year was harder to make these connections as it was their first year back in person, but believed they had a better base to rely on this year.
- Yang stated that based on what they saw on Instagram, the Canada Africa Innovation Fellowship has turned into a start-up venture and thought they were trying to turn a profit. They asked how this relates to trying to benefit the local community. Rahman answered they are not sure how the start-up is working and added that a lot has not been done, it is just in the talks. Rahman added they have been looking for charities to donate to that align with EWB missions.
- Zakkar stated from their understanding they had money left over from last year asked where the extra money they are requesting this would go. Rahman said that last year, they started off with \$20,000 due to Covid and because no money was touched, they were able to spend the entire \$12,000 on one fellow. They said that they are starting off with \$16,000 this year and noted that whatever they have listed in their budget is probably not accurate as they are looking for sponsors. Rahman added they are asking for \$4,000 because they are starting with \$16,000 and if they spend everything, they will be \$4,000 behind.
- Hannan brought up concerns about their parent organizations' ethics/direction and asked if this organization helps them in fundraising. Rahman answered that they are normally supposed to help. They added that they are supposed to have an annual fundraiser, but it did not happen last year and they didn't think it was happening this year. Rahman added they are supposed to assist with larger fundraising events. They noted that national office visited them last year to go over pros and cons.
- Samuels asked for them to expand on Hill Day. Rahman said they thought it would be sustainabilityrelated and noted there is an information session on Wednesday where they will learn more about what will be discussed.
- Hannan asked about the election process for members. Mehrun answered that everyone fills out an application which they go through with their VPs. They added that interviews are held for some roles. Rahman added that for the President position, one applies on their own and the VPs vote for it. They added that VPs are elected through submitted applications.
- Yang stated it was hard to believe that there are fiscally responsible choices being made as there is so much student money going into the fellowship. They asked for clarification on the fellowship. Rahman

answered that \$12,000 spent on one person is a lot and added that a discussion definitely needs to be had with national office.

- Hannan asked how the President and Vice-President positions are being advertised. Mehrun answered they are posted on Instagram and advertised at events.
- El-Kadi asked about their strategies on how to obtain sponsorships. Rahman answered that they prepare a sponsorship package that is then sent out in a mass email.
- Otchere asked how many sponsors they received last year. Mehrun answered they received two last year.
- Thusyanthan asked if there is a reason that the fellow is sent to Africa specifically or if they have considered sending them to a closer nation that still falls within their mission. Rahman answered that they are unsure as to why it is Africa specifically. They added that this has been brought up to national office and that the new CEO is trying to expand from Africa.
- John asked what efforts have been taken to reach out for sponsors. Rahman answered that they have been to industry nights where sponsorship directors network and market their mission.
- Batusic asked what is meant by the term 'chapters'. Mehrun answered that it refers to each different University.

# 2. McMaster Solar Car – Eddy Su and Mark Chen presented

McMaster Solar Car reviewed their presentation with the Assembly.

#### Questions

- Samuels asked what they feel that students stand to gain with Solar Car existing. Su answered they've been representing McMaster in competitions since the early 1990s. They added that previous managers have shown them ads of Solar Car in the Toronto Transit Commission and that the Solar Car competition is what every larger engineering school attends.
- Hannan asked if a date has been set for their information session. Su answered that it's already been held. They added that they are attending McMaster Engineering Clubsfest and that they couldn't attend the MSU Clubsfest as their executives were either on co-op or sick. Su added they intend to participate in future ones and are also in talks with other organizations to conduct outreach.
- El-Kadi asked how ready they felt for next year's competition. Su answered they are very confident that the car will race in 2024 and that the new team is working very hard on the project.
- Thusyanthan asked for an explanation on why the ASC Registration cost is \$13,000 and if it was a good use of student funding. Su answered that the cost is non-negotiable and it was not up to them. They said they do track and road racing and need access to public roads, along with contacting park officials, to be able to secure positions to race in. Su added that they also rent the whole track (NASCAR tracks) for the entire week.
- Batusic asked how many years the recent car has been in progress. Su answered it has been in progress for four years and they have taken many steps to ensure the new team can keep up.
- Hannan asked if they've done anything to create space for students outside of engineering. Su answered
  that they've done posters across campus which specify that one doesn't have to be an engineering
  student or have engineering experience to participate, it could simply be a hobby.
- Thusyanthan asked if the \$16,000 in funding from the Engineering faculty noted in their budget has been confirmed. Su answered they have a meeting with faculty funding next week and cannot give a definitive answer yet, but added that typically, they are very stable and said there's a very high chance they will get it.
- Samuels asked what they have done to mitigate team issues. Su answered the team started back up in 2019 to build this car and back then, there was little documentation and a lot less people to help. They added that team documentation is the most important thing, as well as the verbal transfer of knowledge. Su added that they are doing a lot more this time around, including requiring every team lead to write down procedures as well as creating videos and detailed roadmaps.
- Otchere asked them to continue their answer from the previous question. Su added that they have learnt from past experience to keep at least one car and be able to join a competition.

- Hannan asked about the value of working on the car aside from racing it. Su answered that working on the car is where the most knowledge is gained. They added that racing it would improve McMaster's image.
- Popovic asked how the budget is affected given the materials from a previous car cannot be used. Su
  clarified that the previous cars' parts will not be destroyed, but rather transferred to the new car or used
  elsewhere.
