He informed the Board that this weekend has been designated as a period of time for the nuisance bylaw to be enacted, and that there will be an increased presence of Bylaw and Police Officers. He added that today was the last day to buy tickets for Queer Prom. Wooder gave a shoutout to Maroons for their clothing swap.
