#### 6. Referendum – Request to Suspend Restrictions

**Moved** by Popovic, **seconded** by Hobbs that the Assembly suspend the restriction of holding a referendum with the same question within the current or previous academic year, as per **Bylaw 7, Section 3.5.1.1**, to

allow for the Food Affordability Initiative referendum to be re-run this academic year.

- Popovic explained that running this referendum was part of their platform. They reiterated the concept, which was to offer students soup and bread for potentially up to four days a week, for \$5 per year. Popovic said that the referendum ran last year but missed quorum by approximately 0.5% and therefore, they wanted to run it again. Popovic added that a student group approached them asking to run it again and expressed interest in being involved in campaigning. They explained that this motion is not to vote on the referendum itself, but to receive permission from the Assembly to proceed with running the referendum again.
