Announcements from the Chair

The Speaker reminded all non-SRA members to sign the Observer's List. They informed the Assembly of the open SRA seats for the SRA by-election on October 7th: Engineering (four), Business (two), Science (one), Nursing (one), and Humanities (one). The Speaker encouraged the Assembly to spread the word and directed anyone interested to the Elections page on the MSU website. The Speaker informed everyone that they will circulate an SRA merchandise form soon to get feedback on ideas and place the order after the by-election.

 - OPIRG reviewed their presentation with the Assembly.

Questions

- Hu asked what the duties of the Community Garden Coordinator were.
- Gnanamuttu answered that they worked part time during the summer, for 15 hours per week, and now work five hours per week. They added that they assisted with developing an expansion behind BSB, and getting students involved. They also assisted with hiring volunteers.
- Wang asked how many students chose to opt out this year and if it was an increase or decrease from last year.
- Rawal answered that 180 students opted out this year and was unsure about the yearly comparison but was happy to investigate and provide the information outside of the meeting.
- Batusic asked if they thought they had the funding and necessary resources to spend \$1,000 on advertising for the opt-out initiative.
- Haseeb answered yes, they were able to allocate it into their budget to ensure that students were aware. They noted the goal was to really get the word out there since students are auto-enrolled.
- Schaub asked what they thought their biggest challenge would be in the upcoming year.
- Haseeb answered that OPIRG was expanding very quickly with the garden. They were working with the OPIRG Board of Directors to make certain processes more efficient to be able to support students. Haseeb added that they're able to incubate 9-10 groups at capacity but were in the works of trying to make it more efficient.
- Arora asked what the \$1,000 on advertising specifically went towards.
- Haseeb answered that it went towards their ad in the Silhouette, tabling at The Hub for financial transparency day, ads on campus screens and getting posters and postcards printed.

They added that it had been six years the last Homecoming. They noted a few concerns with the event: the struggle with acquiring volunteers/workers to assist with stations and the slow-moving lines, as Campus Security had closed four out of the six entrance lines, although they were unsure as to why this occurred. Popovic said that the main goal for the event was to bring campus culture back and build a community, while at the same time targeting unsanctioned street parties and putting students in a safer, more positive environment.
