Voter Turnout

Voter turnout for the SRA October by-election 2024 is as follows:

For normal nomination period:

SRA Business: **150** (**4.7%**) of **3186** electors voted in this election. SRA Humanities: **138** (**6.8%**) of **2030** electors voted in this election.

SRA Science: 464 (6.5%) of 7119 electors voted in this ballot.

SRA Nursing: **46** (**5.6%**) of **827** electors voted in this election.

SRA Engineering: **208** (**3.1%**) of **6641** electors voted in this election.

For EXTENDED nomination period:

SRA Engineering: 151 (2.3%) of 6641 electors voted in this election.

Promotional Events & Strategies

Nominations Promotion

For October By-Elections, we had two rounds of nominations. The first round was held from October 7th to October 11th and the second round was held on October 21st to October 25th.

Given the shortened nominations period, we used targeted promotions and emailing towards the specific caucuses that had seats open. Using the undergraduate emailing lists, we sent out individualized emails to each specific faculty to disseminate how many seats were open and the appropriate deadlines and dates. To target the Nursing seat, which has been unfilled for an extended period of time, we previously reached out to MUNSS in the beginning of the academic year to support the promotion of the SRA Nursing seat. Additionally, by ordering a Digital + Print package from the Underground, we circulated posters around campus, and social media posts on Instagram, Facebook and Twitter. Instagram stories and reminder emails were used to remind students of the upcoming nominations deadlines.

We are content with the level of interest generated. Moving forward, we'd like to facilitate more in-person promotions such as additional tabling or events to increase awareness.

Updates

With SRA by-elections now being complete, the DRO and I are now well into the preparations for the upcoming presidential election, so we are looking forward to that.

Challenges

There was a minor issue regarding the voter list for the SRA Science election however it was promptly rectified, and the polling period was extended by a few hours to account for this.

We had a candidate that was automatically disqualified due to the accumulation of enough severe/standard violations to warrant an automatic disqualification. However, we were successfully navigated through this process and communicated well with the candidate.

Success

We were happy with the number of nominations that we received and the interest that was generated for this election, we only had 1 open seat that we needed to extend nominations for.

We are very happy to see a full Assembly!

Next Steps

Appeals Process Complete

The appeals process for this election has now been completed. 2 candidates chose to appeal some of their fines that were decided by the Elections Committee. These appeal meetings ran successfully, and the candidates did not choose to appeal their fines further.

Candidate Reimbursement

With the appeals period now being complete, our department is in contact with the accounting office to work on reimbursing all candidates their original deposit minus any fines accrued during the election.
