### 2. FYC Coordinator Report – report circulated

Masudi summarized the report.

### Questions

- EI-Kadi thanked Masudi for their report. They asked for Masudi's thoughts on how FYC could be more active with First-Year Formal and the collaboration process. Masudi stated that the agreement between FYC and Spark has been that FYC deals with the promotions aspect, and Spark handles the rest. They explained that by the time FYC is elected by the end of September the previous cohort is gone, and planning for the formal is already happening. Masudi added their contract started in August, so it was hard to help with the process until then. El-Kadi stated that it would be helpful to have conversations early on with Spark, so that there would be a mutual understanding.
- El-Kadi asked about EOHSS forms, and if there wasn't a way for other members of the team could submit the forms or by coaching the FYC members to submit themselves. Masudi stated that they were happy to look into that.
- Sweeney suggested having some members on the team who can help with the admin work. They asked what the plan was for the promotions budget line. Masudi responded that they're currently working on an arrangement with P. Scott at the Underground for promotions for residence events. They explained that they will pay \$120 for the first

- Sweeney asked what the key advocacy points were for this year. Masudi responded that FYC has settled on housing, resources for first-year students, and increasing transparency within residences. They added that they're looking into that last point for this year and next, and are looking into ways of holding Residence Life accountable and making sure students are not left in the dark when issues arise.
- Hackett asked what the plan was for doing the takeover style videos. Masudi responded that they will be doing 'A day in the life' and allowing any FYC member to put their name out in the community and showcase what they're doing. Butera asked if they were doing a story or reel format as Macademics wanted to do the same. Masudi responded that they're trying to figure that out, and offered to give Butera the Vice-Chair External's contact information. Hackett suggested connecting with the Media Production Coordinator as well, even if they don't want Comms to help film, as they will be able to offer advice.

# 3. Macademics Report – Serena Butera presented

Scott added that if the OP has (s) beside Coordinator, then they're able to hire more than one without permission, but that the OP could be quickly changed if that isn't the case.
- Hackett asked if Macademics had graphics yet for the exam wellness event. Butera
  responded that they're currently working with Underground on this.
- Arora asked if any of Macademics discretionary spending would be going towards SRN. Butera responded that they would only be paying for promotions of the Awards that get presented at SRN. They listed out the other items they would be spending their budget on.

### Information and Questions

- Wooder stated that an interesting development came forward for the radio station. He explained that the current infrastructure levels will not be supported by Bell starting in 2026. Wooder added that this was a CRTC regulation as well. He stated that they've been struggling to get Cogeco to run fibre but they have found a hub to run it through from the third floor of Gilmore Hall to the basement of MUSC. Wooder added that there were no projections of costs, so it may come to a future EB meeting.
- Scott asked the Board to please circulate their class schedules to her ASAP, as she would like to have the meetings scheduled before the winter closure. She informed the Board that the opt-out reimbursement cheques have been delayed due to the postal strike and hoped that it would be resolved soon but will be looking into alternate methods.
- Sweeney asked what the breakdown between cheques and direct deposits was. Scott responded that she didn't have the numbers in front of her but that typically students chose direct deposit over cheque, so it would be over half of those who opted out.
