**1. Approve the circulated changes to Corporate Documents to comply with the Ontario Not-For-Profit Corporations Act**

**Moved** by A. El-Kadi, **seconded** by Sweeney that the Full Members of the Corporation adopts the changes to **Corporate Bylaw 1 – CFMU Incorporated** and **Corporate Bylaw 2 – Operations** (adopted at CFMU Inc - 24M), and further enact all resolutions as circulated and attached (CFMU Inc - ONCA Resolutions), effective immediately to properly adhere to the Ontario Not-For-Profit Corporations Act.

- El-Kadi went over the motion with the Full Members. They reminded the Members that this was just passed in MSU Inc., and that changes were the same requirements to make sure the organization was compliant with ONCA.
- Sweeney clarified that the changes that came forward to CFMU Inc. in January have been included in Corporate Bylaw 2, but the transfer was still scheduled for May 1, 2025.
