**1. Approve the circulated changes to Corporate Documents to comply with the Ontario Not-For-Profit Corporations Act**

**Moved** by A. El-Kadi, **seconded** by Sweeney that the Full Members of the Corporation adopt the changes to **MSU Corporate Bylaw 1**, and further enact all resolutions as circulated and attached (MSU Inc - ONCA Resolutions), effective immediately to properly adhere to the Ontario Not-For-Profit Corporations Act.

- Jeyakumar asked about section 4 of Corporate Bylaw 1. They asked for A. El-Kadi to clarify the change from being Full Members to Corporate Members and if that would change the membership.
- A. El-Kadi responded that legal council went over these bylaws and changes for hours. They explained that they were just harmonizing the language used within ONCA, and that they were not changing how the MSU or the Corporation worked.
- Jeyakumar asked if the Board of Directors would be considered Corporate Members. Jeyakumar ceded their time to A. El-Kadi.
- A. El-Kadi explained that in order to run for an election, they all needed to be an MSU member.
